



President's LetterSome Thoughts for 2015



As you already may have heard, the LLPOA board is working on a petition to be presented to the Brown County Commissioners for the repair and resurfacing of Chickadee Drive and the repair of Cardinal Drive. By the time you read this, you should have received a copy of the petition. I hope that everyone who is eligible has signed and returned it. We are planning to present the petition to the Commissioners in March. In order for this effort to have any impact, our concerns must be presented as soon as possible and have the support of everyone. Once we know the date of the Commissioner's meeting at which time our petition will be presented, you all will be notified and your attendance to show support for our concerns will greatly improve our chances for success.

Just a reminder, your annual LLPOA dues were due by January 31, 2015. The dues are a critical to maintaining our lake, and servicing the SBA disaster assistance relief loan. Last year we cleaned out 80 truckloads of silt from the two silt pits at a cost of over \$24,000. That's 80 loads of silt that did NOT flow into our lake. Also, we have made great progress in paying down the SBA loan, which requires a minimum annual payment of \$17,832. It is my hope that we can make future principle payments that will pay off the loan more quickly. We all have a vested interest in maintaining the quality of the lake itself which in turn enhances our property values. If anyone would like to set up a payment schedule, please contact Linda Schwaner, Treasurer. .

The meeting was called to order at 6:35 at the home of Charlie and Mary Backofen. The minutes of the October, 16, 2014 meeting were read and approved with a motion by Harry Hicks and a second by Carolyn Giblin. Motion passed.

In order to make official the changes in positions from the fall meeting, Harry Hicks, nominated for Vice-President and John Slater, nominated for a Director, were confirmed by a motion made by Carolyn Giblin and seconded by Jared Sawyer. Motion carried.

President Backofen had received notice from IDEM of our final inspection and present at that inspection were Joe Giblin and he with two representatives of IDEM in late October. Since then two letters from IDEM have arrived, one from the Deputy Assistant Commissioner of Water Quality that has released LLPOA from monitoring requirements; and the second from the IDEM Enforcement Branch stating that LLPOA has complied with the Agreed Order and the issues are resolved and closed. From here on, the designated section on the west bank of Thunder Creek will remain unmowed, the IDEM Restoration sign will permanently remain, the loss of any trees or bushes below the number required will be observed with restoration and preparedness for a random check by IDEM is in place. ALL the IDEM documents and correspondence will be placed in the LLPOA lock box at First Merchant's Bank, Morgantown. The required environmental notice has also been filed with the Brown County Recorder's Office.

Charlie also stated that he had completed and filed the LLPOA tax return on December 19, 2014. The LLPOA is a not-for-profit organization and a tax filing is required each year. It is also a requirement of our SBA Disaster Assistance Relief Loan 2009.

Treasurer, Linda Schwaner reported that all 2014 dues were in with two exceptions. Partial payments have been received with a sizable balance due for lots 92/93 and there has been no payment for Lot 79. The mowing contract with Affordable Services was approved at the same amount as last year.

An audit will be done within the next quarter.

Mary Backofen, Secretary, reported that she had prepared the petition to the Brown County Board of Commissioners for the LLPOA board to peruse and edit. After brief discussion and the addition of clarification on the type of "hard surface" of the road repair, there was general agreement to move forward. Mary will e-mail those on our LLPOA e-list with a heads-up of the petition, its contents, delivery and return options. She will hand deliver the petitions to many permanent residents and mail petitions along with a stamped return envelope to non-permanent residents. Also, ALL property owners on each road who are not part of Lake LaSalle Estates are receiving the petition. This will total approximately 85 mailings. In February, she will present all the petitions with a cover letter at the Office of the County Commissioners in Nashville with a request to be on their agenda in March. Property owners will be informed of the exact date and will need to be present to support the petition.

Carolyn Giblin, Complaints and Compliances, had only one call for information in the last quarter. This related to the upkeep and traffic on a shared driveway. As the concern is on private property, she encouraged the caller to do a personal contact with the property sharer.

Joe Ridenour, Entertainment, reported a low response to his flyer regarding a Euchre Tournament on January 16th. As a result, he and Sandy are hosting those interested at their home rather than at the church site.

There was no winter fishing report from Jared Sawyer.

Jon Schwaner, Communications, had no report but again requests articles, photos, etc. from our membership for the newsletter. John Slater, Long Range Planning, had nothing to report but did share that the need for sewers could impact us sometime in the future.

Joe Giblin, Maintenance, said the two posts downed by a car on LaSalle Road near the boat ramp will have to be paid for by the LLPOA. The hit-and-run damage was called to the police who investigated the site and a lead of the specific information that was available about the car that was involved. But that lead was not supported by any property owner. Also, the spillway cage will be painted next summer and Joe will need volunteers to help. The flag and solar cap on our new flag pole were removed in October to avoid winter damage. The inexpensive flag was already tattered and a new one has been donated by Peter Frenzel to replace it. Initially, there was a request for the flag pole to fly the American flag and a Lake LaSalle flag. The cost and design of a LaSalle flag will be researched for presentation at the April board meeting. The original Lake LaSalle boat stickers from the early 70's had a cameo of a depiction of the explorer, LaSalle, which may become a visual on the flag. Finally, John Slater volunteered to address with the private owner the LLPOA's past mowing of the private dam adjacent to our boat launch near Lot #12.

Mary Backofen made the motion to adjourn at 8:10 and it was seconded by John Slater. Motion passed.


MEET YOUR NEIGHBORS
