Lake LaSalle Property Owners Association Board Meeting Minutes - 07/20/17

The meeting was called to order at 6:30pm at the home of David LaFon - Secretary.

Present were Ed Ranard President, Vice President Charlie Backofen, Treasurer Dan Jackson, Secretary David LaFon, Jared Sawyer, Joe Giblin, John Slater, Joe Ridenour, Kurt Ellinger and Sally Gindling

The minutes of the April 20th 2017 were sent to all board members to read ahead of time. There was a motion to approve the minutes by Dan Jackson and a second by Sally Gindling. Motion passed.

<u>President – Ed Ranard</u>

Ed indicated that there was some interested in Non-Board members attending the Board meetings. They cannot participate in the decision making process. If Non-Board members attend, we will move new business to the top of the agenda. Ed has been referring people to the website for information on Lake LaSalle. Please let Kurt know if there are any issues or corrections to the website. New signage at Cardinal and Chickadee. Ed spoke to Tammy on Chickadee about trimming trees around the signage. Tammy requested a document from the POA indicating that she gave permission for the signage to be placed on her property. Copy of document given to Secretary.

Brown County Water has been working on yard/driveway restorations. Looks like they have been doing a good job. The issue with the member with an incorrect motor size has been resolved.

Charlie called Dale Sizemore on removing silt from Thunder Creek. Need to educate members on how Thunder C reek impacts properties. Ed and David fished out large logs and vegetation along their canal. Will end up at the bottom of the lake and impacts boating and fishing in the Spring and Fall. Canal needs to be maintained. The last time the canal was cleaned out was when the lake was dredged in 2008. Charlie said Dale brought up this issue previously. Dale suggested lowering the lake 4-5 feet to clean out the canal. Dale has great knowledge of the lake and does not think it would be an issue to do. Will talk to Dale about getting an estimate. It would be a good operating for members to fix/repair their docks. No need to get IDEM involved in lowering lake 4-5 feet.

Issue with Lot #104. Letter was sent in June for homeowners to clean up the property. There was no response.

Complaint from Lot #105 stating they have been unable to sell their home due to the issues from Lot #104.

POA sent a letter from our attorney, Matt Barr, to Lot #104 owners sighting State Statutes. There are still large amounts of brush on Lot #104 that needs to be removed. Lot #104 will need to provide updates on cleanup process. They were given 6 months for completion. If not completed, POA will file a nuisance order with the courts.

Lot #104 owners cannot burn the brush.

POA is working on a new payment policy (Executive Resolution #3). Additional details to follow. Will present at the Annual meeting. Sally made a motion to table the issue and Jared second, until proper wording is approved. Motion passed. 3 People currently on a payment plan and 1 lien to be filed on/after July 24th, 2017 for Lot #20.

Treasurer - Dan Jackson

reported the following account information:

Checking: \$38,181.69 Savings: \$14,969.74

SBA Loan: \$44,253.00 with payoff amount of \$44,388.79

The POA books were audited and passed.

The following Lot #'s have not paid their dues in full: Lot # 20. Lien to be filed on/after July 24th, 2017.

Reminder- Liens will be placed on any property where dues have not been paid in full by July 1st. A 10% late fee and filing fees (\$50.00 each property) will be added to the property owner's balance. If a property owner owns more than one lot, liens will be placed on all of the property owner's lots. Any Associate members that does not pay Lake LaSalle Association dues are not allowed on the lake.

Secretary - David LaFon

Had nothing to report.

Complaints - Joe Giblin

Lot #21 dock needs repair. Gave him until July 15th. Had 1 boating complaint, but it was determined that boat was not exceeding the speed limit. Lot #44 property is a mess. Kids trying to sell house. Owner in nursing home. Need to send a letter and give 30 days to clean up the property.

Entertainment - Joe Ridenour

Last friendship breakfast had approximately 30 people attended. Last 2 previous events had at least 30 people attend. Joe has decided not to pursue another term on the POA Board.

Fishing - Jared Sawyer

Had water testing done at the coffer dam and middle of the lake. Waiting on results. Will need to do testing once/twice a year. Jared also requested an estimate from Jones Fish. The estimate, which was submitted late, was lower than Aquatic control for the same services.

Long Range Planning - Sally Gindling

Still working thru old documents. Sally knows Dr. Bosch and he is working on a water testing plan for us, free of charge.

Maintenance - John Slater

Looking at Ashberry Dam. Vegetation on side of Dam. Ditch between the small lake and Lake LaSalle is most serious. The ditch is being washed out and needs repair. Trees and roots needs to be removed and replaced with dirt. Also, need tree removal from

Hilficker cove.

Communications - Kurt Ellinger

Annual Water Quality Care

Aquatic Control Inc. of Seymour applied their professional algae and weed control treatment Monday, July 17. The addition of the yellow information markers was new this year.









Our lake was recently tested for E Coli levels. According to EAI Labs, we have a safe lake to swim in.. The board is planning to submit another 3 samples at the end of this month from Thunder Creek, Lawrence Creek, and Hilficker Cove inlets.

Additionally, we are looking again into the green globs of algae. There may be a way simple way to clean them up without spraying excessively with Algae treatments. Continued treatments may not be working to our advantage so further research is necessary. We will continue to investigate.
